**Subject: Workshop on "Best Practices in Environment Management in Fertilizer Industry", 9-11 May 2018, Hotel Fortune Park Sishmo, Bhubaneswar, Odisha**

Fertilizer industry has been adhering to all statutory environmental standards and following best practices to go much beyond the statutory requirements. The Ministry of Environment Forests and Climate Change has notified the revised Environment Protection Standards for Fertilizer Industry in December 2017. There is also new requirement of Online Continuous Emission Monitoring Protocol prepared by CPCB. In addition, there are regulations notified in recent past including for hazardous waste management, e-waste, plastic waste management and sewage treatment plants. Fertilizer plants have installed or are in the process of installation of instruments and systems for monitoring and control to comply with the latest regulations. There is need to take stock of situation and review the developments in the area of environment.

In this context, we are organizing a 3-day residential Workshop on "Best Practices in Environment in Fertilizer industry", during 9-11<sup>th</sup> May 2018 at Bhubaneswar. The Workshop will include presentations and case studies on environment related topics. Technology vendors will be invited to make presentations on latest developments. Officials of Central and State Pollution Control Boards will also be invited to participate in the discussion. A visit to the facilities of IFFCO and PPL, Paradeep is also planned.

The Workshop is designed for executives responsible for environment activities in ammonia, urea, acid and complex fertilizer plants. The participation fee for the three-day residential Workshop is Rs 17,500/- (Rupees seventeen thousand five hundred only) per person plus GST on double occupancy and Rs. 23,500/- (Rupees twenty three thousand five hundred only) per person plus GST on Single Occupancy. The registration fee includes workshop material, boarding and lodging for 3 nights in Hotel Fortune Park Sishmo, Bhubaneswar, Odisha. The registration fee may be sent to the FAI in form of a demand draft drawn in favour of Fertiliser Association of India, New Delhi or through NEFT/RTGS transfer as per details given separately.

It is requested that nomination(s) should reach us latest by 25<sup>th</sup> April, 2018 by fax/email/post. The nominations received after the last date will be subject to availability of rooms in the hotel. While substitution of name with other participants is admissible, any cancellation of confirmed nomination(s) after 25<sup>th</sup> April, 2018 will be charged 50% of the participation fee. ## Information Sheet

### **Workshop on Best Practices in Environment Management in Fertilizer Industry 9-11 May 2018, Hotel Fortune Park Sishmo, Bhubaneswar, Odisha**

#### **1.0 Tentative Programme**

The programme will start on 9<sup>th</sup> May 2018 at 1500 hrs with Inauguration and few presentations and will conclude on 11<sup>th</sup> May 2018. There is a plant visit planned on 11<sup>th</sup> May 2018 and participants are expected to be back by 0800 PM in the evening.

Focus of the Workshop will be on information sharing amongst the participants. We are inviting industries to make presentation. Participants may also present case studies. The programme will also include one-day visit to facilities of IFFCO and PPL at Paradeep. These plants operate large size acids and complex fertilizer plants. The participants will have an opportunity to see the new phosphogypsum stack which are under construction at both the sites and other initiatives undertaken by plants to improve environment.

#### **2.0 Accommodation**

The stay arrangements for the participants have been made at Hotel Fortune Park Sishmo, Bhubaneswar. It is about 5 kms from Airport and about 1 km from railway station. The hotel is equipped with all the modern facilities. The package will start with Lunch on 9<sup>th</sup> May and end with Breakfast on 12<sup>th</sup> May 2018. However, for any additional expense such as extra stay, room service, guests, telephone calls, laundry, beverages, etc., the participants will have to pay directly to the hotel.

#### **3.0 Check in and Check Out**

The participants should check in on the noon of 9<sup>th</sup> May, 2018 and check out by noon of 12<sup>th</sup> May, 2018. For any overstay, the participants will have to pay to the hotel directly. The participants may make their travel arrangements accordingly. An optional Visit to Puri and Konark can be arranged on 12<sup>th</sup> May 2018. Participants may check out on 12<sup>th</sup> May morning and leave for the visit and return by 5:00 PM in the evening. Interested participants may inform in advance so that same can be planned.

#### **4.0 About Bhubaneswar**

Odisha's capital city, Bhubaneswar, is a renowned tourist destination. The city has gardens, natural wonders, monuments and stunning architecture. However, the city is prominently known as the 'City of Temples' as it is home to nearly 700 temples. All temples are a fine work of art with heavily sculptured features and outstanding architecture that dates back centuries. Bhubaneswar also plays an important role as a regional gateway to the Golden Tourist Triangle of Puri, Konark, and Chilika Lake. Its strategic geographic location along the east coast of India, has positioned Bhubaneswar to serve as the gateway to South-east Asia with easy access to existing and emerging ports, petrochemical and steel hubs at Paradeep, Kalinganagar, Dharma and Gopalpur.

#### **5.0 Climate**

Bhubaneswar is located on the coastal plains of Odisha (Orissa), south-west of the River Mahanadi. It experiences typical tropical weather conditions, and succumbs to the heat and cold waves that sweep in from north India. Minimum and Maximum temperature expected during the period are 26°C and 38°C respectively.
